

Firms Hold Back on Attorney Hires for Second Year

Numbers Again Flat After Modest Post-Recovery Gains

By DEIRDRE NEWMAN

Law firms in Orange County held attorney counts steady over the past year for the second year in a row after two years of modest gains.

This week's Business Journal list features 88 firms with headquarters or significant operations in Orange County, ranking them by the number of local attorneys as of Feb. 28. It includes other data, such as firmwide attorney totals and the overall number of local employees, accounting for paralegals and administra-

tive staff, though those figures don't affect the rankings.

This year's list is the longest yet, thanks to increased research capacity and growth in the number of firms to make the cut of a minimum

OC attorneys at ranked firms numbered 2,681, flat year-over-year. There were 1,236 partners among them, up 1.5%. Overall employment was at 5,275, a 1% increase.

The top three firms kept their ranks:

■ Irvine-based Knobbe Martens Olson & Bear LLP, which tops the list, has 164 locally based lawyers, the same as a year ago. It added one partner over the year and had 470 total employees in Orange County, down 1.5%.

■ No. 2, Costa Mesa-based Rutan & Tucker LLP, had 133 lawyers here, down by two. The firm cut three partners and had 265 OC employees overall, up by 3.5%.

■ Newport Beachbased Stradling Yocca Carlson & Rauth P.C., No. 3, with 86 attorneys based here, was down by one. It dropped one partner and two employees overall.

■ The Costa Mesa office of Sheppard, Whyte: attributes Mullin, Richter & Bremer Whyte's



Dunn & Crutcher LLP switched positions on the list, Sheppard Mullin taking the No. 4 spot as it held steady with 72 attorneys. Gibson Dunn's attorney count dropped by five, or

■ The top 10 firm with the biggest attorney growth was Newport Beach-based Bremer Whyte Brown & O'Meara, which added eight local attorneys, or more than 17%. It lost one partner but added 11 employees overall, moving up from No. 12 to No. 9.

Co-founding Partner Nicole Whyte attributes the growth to the vision of the founding and managing partners in the firm's early years. She and Keith Bremer created it 20 years ago with an early focus on construction defects cases.

"We saw the writing on the wall early on and predicted this area of practice would slow down in the future," she said via email. "We made a strategic decision early on to diversify the practice areas of the firm, diversify the client base, and focus on organic growth from within-by hiring young lawyers, mentoring them, and bringing them up in the firm to become leaders. Today we are a full-service law firm with multiple areas of practice and a

O'Hare as head of Snell's Orange County office in January, said that attorney turnover is a "very common occurrence across the legal landscape and [its] rate is actually in line with the national average," adding that turnover can be attributed to many factors, including operating in "a very competitive marketplace, evolving shifts in legal trends, and varying workplace prefer-

"As always, our focus as an office is on driving strategic growth, enhancing efficiencies, and continuing to provide our clients with outstanding legal services," Vakil said via email.

■ The Irvine office of West Harrison, N.Y.based Jackson Lewis P.C., which debuts on the list at No. 31, experienced the most growth on the list-50%-adding 10 attorneys, to end the time period with 30. It added three partners and 12 employees overall.

Orange County office Managing Principal Samantha Hoffman credits its growth to her

"We have a great and diverse group of attorneys and staff in Orange County who understand how important teamwork and camaraderie are, which in turn ensures quality lawyering, responsiveness, and our ability to bring the best team to bear on a particular matter or client," she said via email. "This, in turn, leads to a great deal of work from external clients, as well as our colleagues throughout the firm."

■ The Irvine office of Pittsburgh, Pa.-based K&L Gates LLP, No. 38, had the least growth, 10 attorneys-or 27%. There were two partners among them, and it lost 13 employees overall.






Growth Levels Off




OC Partners

Paying Most Sales Employees Purely on Draw and Commission No Longer Lawful In California

Last month a California appellate court held that an employer violates California law by paying inside sales employees on a draw against commission. In Vaguero v. Stoneledge Furniture LLC, the court held that such a pay arrangement does not compensate employees for their mandatory paid rest breaks.

This decision is the latest in a line of cases in which California courts have rejected the approach taken under federal law to determine whether employees are paid at least minimum wage for all hours worked; i.e, divide total hours worked into total earnings for the pay period. Under the federal law approach, if the result of this calculation is at least the minimum wage, the employee's pay is sufficient.

Not so in California. In recent years. California courts in piece-rate cases have held that the piece-rate only compensates the employee for productive piece-work, not for other working time such as training time, meetings, waiting time between jobs and paid rest breaks, when the employee is "on the clock" but not performing piece-work. These courts have held that employees must be compensated separately for such non-productive time.

The Vaquero case extended this rationale, in part, to commission-paid inside sales employees. The employees in that case were paid a draw every pay period that amounted to at least minimum wage for all hours worked. Because the draw was recouped from commissions, however, and the commissions were paid only for sales work, the court held that the draw against commissions arrangement did not compensate the employees for their mandatory paid rest breaks.

As a result of the Vaquero case, employers that pay inside sales employees purely on a draw against commission basis must change their method of paying such employees. on paid rest breaks and pay them draw against commission basis. separately for such time at a rate that

is at least minimum wage. While AB 1513, effective January 1, 2016, requires that piece-rate paid employees be paid for rest breaks at an average of their piece-rate earnings for the work week (they may be paid minimum wage or higher for other non-productive time), this law states specifically that it applies only to piece-rate paid employees and the Labor Commissioner has indicated that it does not apply to commissionpaid employees. Thus, unless the legislature expands AB 1513 to cover commission-paid employees, such employees need only be paid minimum wage or higher for paid rest breaks.

Another method would be to pay sales employees an hourly rate of at least minimum wage for all hours worked, including paid rest breaks and non-selling time, plus a commission or productivity bonus tied to sales results. The commission would ordinarily need to be at a lesser rate than paid under a draw against commission arrangement since each employee will already be paid at least minimum wage for hours worked. Under such an arrangement, an overtime premium would have to be paid on the commission or bonus, and given the reduced commission amount, it will in most cases be more difficult for the employee to qualify for the "inside sales" exemption from overtime which requires that more than half the employee's compensation be in the form of commissions.

Outside sales employees, who spend more than half their time away from the office engaged in selling activities, are not affected by the Vaguero case because the minimum wage law does One method of doing so is to have not apply to outside salespersons. employees log the time they spend They may continue to be paid on a




