ATLANTA – Annette Michelle "Shelli" Willis, a partner in Troutman Pepper's Real Estate Practice Group, has been named among *Atlanta Business Chronicle's* 2022 Women of Influence. Each year, the publication honors businesswomen who have become trailblazers in their fields and led strong growth in their companies while also giving back to their communities.

Honorees were selected from more than 200 nominations. A six-person committee, which included members of the editorial team, community and past honorees, evaluated the nominees to choose the 21 winners.
