Dove, who is currently serving as vice chair, will begin a one-year term on Jan. 1, 2026.

The Board of Regents is the constitutional governing body of the USG. The system oversees 26 public colleges and universities, including the University of Georgia (UGA) and the Georgia Institute of Technology, as well as the Georgia Public Library Service and the Georgia Archives. It serves more than 364,000 students.
