After working in private practice as an environmental, toxic tort and commercial litigator, Kaplowitz served for five years in the Office of the Solicitor at the U.S. Department of the Interior as legal counsel for BOEM's Office of Renewable Energy Programs and the Bureau of Safety and Environmental Enforcement. During his tenure, Kaplowitz helped revise BOEM's offshore wind regulations and defend BOEM against legal challenges to its permits and leases. Kaplowitz then moved to an in-house position with GE's offshore wind business unit.
