**October 18, 2022** – Locke Lord has achieved Mansfield Certification Plus status for 2022 from Diversity Lab, recognizing the Firm for reaching targets designed to boost the representation of diverse lawyers considered for a variety of roles and opportunities within the Firm.

Mansfield Rule Certification measures whether law firms have affirmatively considered at least 30 percent women, underrepresented racial or ethnic groups, LGBTQ+ lawyers and lawyers with disabilities for top leadership roles, senior-level lateral hiring, promotions into the equity partnership and participation in client pitch meetings. Mansfield Certification “Plus” status indicates that, in addition to meeting the baseline certification requirements, Locke Lord has successfully reached at least 30 percent underrepresented lawyer representation in a notable number of current leadership roles.
