## ALUMNI NOTES

As the crisis in Ukraine erupted into war, we learned of many Troutman Pepper colleagues with family and friends in Ukraine and in the countries that are receiving refugees. As a result, the firm worked with the American Red Cross to raise money to support humanitarian efforts on behalf of those affected. Troutman Pepper attorneys and staff (including several retired alums) donated \$106,000 to the American Red Cross, which the firm matched dollar for dollar.
