In 2018, Campbell acquired the Emerald nuts business as part of the Snyder's-Lance, Inc. acquisition. The Emerald business generated net sales of \$66 million in fiscal 2022 and \$46 million for the nine-month period ended April 30, 2023. The company does not expect the divestiture to have a material impact to its fiscal 2023 financial results.
