The Compass Award recognizes individuals and organizations that fulfill all of the following requirements in a single calendar year:

- Nominate an LCLD Fellow
- Nominate an LCLD Pathfinder
- Participate in an LCLD Pipeline Program (the 1L Scholars Program or the Success in Law School Mentoring Program)

This year, 47 Member organizations were named Top Performers, 40 were named Compass Award winners, and Troutman Pepper was among the 111 organizations who earned both designations.

Since the organization's inception in 2009, Troutman Pepper has participated in several LCLD programs, including its Fellows, Alumni, Pathfinders, and 1L Scholars programs.
