# Troutman Pepper Locke Delivers Double-Digit Gains in Q1 2026 US Private Equity and Venture Capital League Tables

**NEW YORK** – Troutman Pepper Locke achieved double-digit gains across Q1 2026 league table rankings, earning multiple top 15 and 25 positions from *PitchBook*, *LSEG*, and *The Deal*. These results underscore the firm’s strong momentum and continued outperformance in the private equity and venture capital markets after completing its first year as a combined firm.

*PitchBook*’s first quarter Global League Tables again ranked the firm among the most active U.S. private equity and venture capital counsel, highlighted by significant climbs in health care private equity, where the firm rose to No. 8 from No. 19, and in health care devices and supplies venture capital, where it rose to No. 6 from No. 16. The firm also secured new top 25 rankings in B2B, consumer, and other high-growth sectors.
