### ***Clinic Named After Troutman Pepper Locke Partner Ben Wagner Celebrates Visionary Leadership in Utilizing Intellectual Property to Drive Global Humanitarian Efforts***

**SAN DIEGO** – Troutman Pepper Locke has played a pivotal role in advancing global humanitarian efforts through the firm's strategic intellectual property pro bono support for FERMBLOC foam blocks, used by a host of nonprofits, including firm client Lazarian World Homes (LWH) and International Hope Builders (IHP), two nonprofit organizations that provide critical infrastructure in developing regions.

In a remarkable gesture of appreciation, IHP dedicated a newly constructed medical clinic in Honduras in honor of Troutman Pepper Locke attorney Ben Wagner. Built using the patented FERMBLOC technology, the Ben Wagner and Family clinic is set to deliver crucial health care services to hundreds in the local community, demonstrating the profound influence that pro bono legal assistance can have in fostering sustainable development and improving lives.
