Law360's data-driven rankings emphasize performance and reputation, showcasing the firm's adaptability and leadership.

The Law360 Pulse Leaderboard highlights law firms that excel in prestige, diverse practice expertise, and socially responsible business practices. The rankings evaluate firms based on three pillars: prestige, social impact, and practice footprint. Using data from Law360 Pulse surveys, LexisNexis platforms, and the Metabase news database, the top 100 firms are identified as benchmarks for excellence and integrity in the legal industry.

The Law360 Pulse Prestige Leaders report measures performance across four key indicators: financial success, desirability among talent, editorial awards, and positive news representation in top legal publications. Scores from these indicators are averaged to determine the top 100 firms.

The Law360 Pulse Social Impact Leaders ranking measures law firms' efforts in racial diversity, gender equality, employee engagement, pro bono work, and responsible business practices. Scores for each pillar,

weighted at 60% for core metrics and 40% for supporting data, are averaged to produce an overall social impact score. Firms are evaluated against peers of similar size, with the top 100 qualifying based on normalized scores.
