### MARYLAND AG CREATES OFFICE OF THE SOLICITOR GENERAL

On November 10, Maryland Attorney General (AG) Anthony G. Brown announced the creation of an Office of the Solicitor General within his office. This new division is dedicated to overseeing the state's appellate litigation in both state and federal courts. Brown appointed Julia Doyle, a seasoned appellate litigator and current chief of the Office of AG's Civil Division, as the new solicitor general, effective January 8.

### KENTUCKY AG CHECKS THE BOARD OF PHARMACY'S REGULATORY POWER

On November 12, the Kentucky attorney general (AG) issued a formal opinion, concluding that the Kentucky Board of Pharmacy lacks the authority to regulate nonresident pharmacists beyond what is specified in KRS Chapter 315. The board cannot mandate Kentucky licensure for nonresident pharmacists, except for the pharmacist-in-charge per KRS 315.0351(1)(g). Therefore, the board's proposed amendment to 201 KAR 2:030, which would require all out-of-state pharmacists filling prescriptions for Kentucky residents to be licensed in

Kentucky, exceeds the board's statutory authority.

The tipping policy in question was in place between 2017 through 2019.
