The USPTO’s Patent Pro Bono Program was established under the 2011 America Invents Act as a nationwide network of independently operated regional programs that match volunteer practitioners with inventors for the purpose of securing patent protection. Troutman Pepper is among 23 corporations and law firms recognized for contributing significant hours to one or more participating regional programs.
