The Virginia Court of Appeals issued a first-of-its-kind emergency stay order and reversed the final judgment by the Chief Judge of Fairfax County Circuit Court. The ruling clarified that out-of-state judgment creditors must comply with Virginia's post-judgment discovery statutes under the Uniform Interstate Depositions and Discovery Act (UIDDA) in *Patel v. Rabinowitz*, 75 Va. App. 663, 879 S.E.2d 60 (2022).
- Secured a favorable ruling for one of the major U.S. banks in a high-profile class action lawsuit concerning unauthorized mortgage forbearances during the COVID-19 pandemic, resulting in the partial dismissal of the Third Amended Complaint after nearly three years of litigation.
- Successfully defended an oral health company in a lawsuit brought by the D.C. Office of the Attorney General related to the company's use of release agreements containing confidentiality provisions for customers falling outside the explicit refund policy.
- Representing a non-bank entity in its response to a CFPB inquiry related to allegations of usury law violations.

- Advised a water technology company in connection with state procurement laws for emergency contracts and full-service water and wastewater O&M agreements in the Northeastern U.S.
