OVERVIEW

Ben is a top-ranked intellectual property, advertising, and complex commercial litigator who has handled hundreds of disputes for clients ranging from startups to multinationals with globally recognized brands. He is a seasoned trial attorney with experience in a diverse range of industries, including the music industry, software, UX/UI, fintech, life sciences, medical devices, real estate development, apparel, consumer goods, and professional sports. Ben's clients span the U.S., Europe, and Asia.

Ben is a devoted advocate for both plaintiffs and defendants, tailoring litigation strategies that address the unique issues in each case, delivering over \$300 million in value in recent years. In just the past year this includes \$70 million recovered in judgments, settlements, and payments for rights holders, and another \$85 million in the decade before that. During this same time, he has defeated more than \$150 million in claims. He currently represents portfolios exceeding hundreds of millions of dollars in estimated value across a broad spectrum of rights holders.

Ben has pursued and defended claims in state and federal courts across the U.S., in international arbitration involving South America, Asia, the Middle East, and Western Europe, and in proceedings before the Trademark Trial and Appeal Board (TTAB).
