

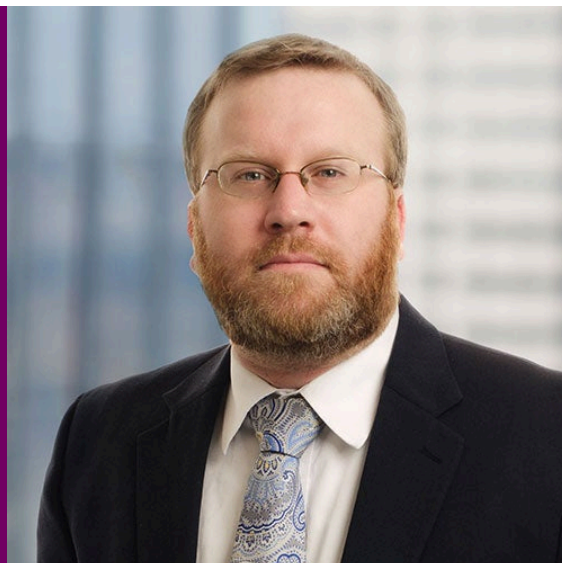

### OVERVIEW
