### OVERVIEW

Craig founded and leads the firm's interdisciplinary Renewable Energy practice. He represents investors, developers, sponsors, utilities, lenders, lessors/lessees and credit support providers across the full lifecycle of renewable projects, including utility-scale and distributed solar, wind, storage, and hybrid assets. His work centers on construction financing, partnership flips, sale/leasebacks, leveraged transactions, take-out debt, merger and acquisition transactions, the securitization of financial assets, synthetic leasing, secured lending, and bankruptcy.

Craig has served as counsel in more than 600 renewable energy transactions involving a variety of assets and jurisdictions. He has advised in matters involving power and energy generation and distribution facilities as well as maritime assets, telecommunications equipment, real estate, waste facilities, and manufacturing plants. In addition to U.S. domestic transactions, he has closed many cross-border transactions in connection with assets or counterparties located in, among other jurisdictions, Australia, Austria, Belgium, France, Germany, Hong Kong, Japan, Mexico, the Netherlands, Portugal, South Korea, and the United Kingdom.

Craig authored the solar energy chapter of the ABA Treatise, *The Law of Clean Energy*, and has earned industry recognition from *Chambers and Partners* as a Recognized Practitioner in Renewable Energy, from *The Legal 500* in Renewable/Alternative Power and Project Finance, and from *Thomson Reuters* as a Stand-out Lawyer. ## **Distributed Generation**

Craig has acted as counsel to some of the nation's largest banks in the creation, negotiation, and documentation of several solar PV funding programs providing debt and tax equity financing for rooftop and ground-mounted distributed generation systems, including:

### *DG Program I:*

- Advised in the negotiation and documentation of three-tiered financing facilities covering several commercial and industrial (C&I) distributed generation projects sited throughout the U.S. The representation involved the structuring and drafting of solar leases tailored to the distinctive regulatory landscapes of numerous states, the unique challenges of financing municipal offtake agreements, the negotiation of high-profile portfolio PPAs, the permitting and environmental obstacles presented by the development of landfill sites, and the navigation of new virtual net metering programs in multiple states.
- In an extensive leaseback program for a distributed generation solar project, drafted and negotiated the project-level lease and security documents as well as amendments to the master lease financing documentation. Further, we leveraged our expertise in RES-BCT tariff and virtual net metering issues to effectively represent our client.
- Through these programs, the tax equity investor invests in solar PV systems developed by a pioneer of the solar power purchase agreement (PPA) model. The financing structure we helped to develop for this program in 2007 was used successfully for more than nine years, pooling multiple solar systems into a single investment fund to simplify the development process and mobilize capital efficiently. Systems are subject to long-term PPAs with commercial and municipal (schools, utility districts, etc.) customers.

### *DG Program II:*

- Launched in June 2009, this solar financing program was established to fund commercial scale solar systems developed by one of the world's most advanced module manufacturers and solar project developers. We assisted the equity investor in this program in which the developer designs, builds, operates, and maintains the customer-sited solar systems and sells power to its customers through long-term PPAs.

### *DG Program III:*

- These programs have enabled some of the U.S.'s largest companies to install solar systems to reduce their electricity costs and environmental footprint. We represented multiple investors in these programs, including helping to finance one of the largest rooftop solar PV projects in the U.S. on a site in New Jersey, as well as seven systems on major retail stores throughout Southern California.
