### OVERVIEW

Dabney's broad litigation background and trial experience make him an effective courtroom advocate and a pragmatic strategic advisor. He efficiently manages highly complex cases and helps his clients meet their business objectives.

Dabney has served as lead counsel to clients on a wide range of matters, including patent infringement litigation, cutting-edge environmental disputes, and product liability claims involving complex medical and technical issues. Dabney is particularly known for his experience in the "rocket docket" of the Eastern District of Virginia, which is regarded as the fastest-moving court in the U.S. His background also includes litigating complex construction defect cases and catastrophic personal injury claims.
