### OVERVIEW

Daniel leads the firm's natural gas pipeline practice, where he advises a broad array of clients on regulation, competition, and transactional issues. He helps his clients develop and construct large natural gas infrastructure and technologies, and addresses regulatory concerns involving liquified natural gas (LNG), compressed natural gas (CNG), and renewable natural gas (RNG) production, transportation, and distribution.

Daniel represents natural gas pipeline and storage companies, local distribution companies (LDCs), electric utilities, generation owners, and energy trading companies in proceedings before the FERC, state public utility commissions, and the U.S. Courts of Appeals, particularly in matters related to administrative complaints and litigation, merger proceedings, rate-making and certificate proceedings, and investigation and compliance matters. Daniel also counsels his clients on novel issues related to strategic planning and commercial matters within the pipeline and energy industry.
