- *SKS Holdings LLC v. Kaplan*, 2023 WL 3262465 (N.J. Super. Ct. App. Div. May 5, 2023). Affirming summary judgment dismissal of conspiracy claims against co-chairman of GlobusMax, Ltd., an Israeli movie theater company, arising out of the development and operation of movie theaters.
- *Dana Transport, Inc. v. PNC Bank, Nat'l Ass'n*, No. L-2095-16 (N.J. Super. Ct. Ch. Div. Aug. 18, 2023). Granting motions for reconsideration and summary judgement dismissing plaintiffs RICO claims in connection with dispute arising out of commercial lending relationship.
