Bringing more than a decade of high-caliber in-house experience at one of the Pacific Northwest's largest utilities, Dustin leverages his extensive knowledge of hydropower and energy regulatory issues to help the firm's energy sector clients effectively and efficiently navigate federal and state regulatory landscapes.

Dustin focuses on guiding clients through complex hydroelectric relicensing, license surrender, and license compliance processes before the Federal Energy Regulatory Commission (FERC) and other federal and state regulators. He is uniquely positioned to advise hydroelectric asset owners on high-stakes FERC hydropower proceedings, given his central role in navigating the successful FERC license surrender proceeding for the Lower Klamath Hydroelectric Project in California and Oregon, as well as the numerous state and federal regulatory requirements that applied to the largest dam removal effort in history. Working effectively with federal and state regulators, Native American Tribes, and other stakeholders, Dustin helped craft the legal, regulatory, and political strategies that delivered a balanced outcome, which included core utility business and customer protections, and resolved one of the nation's most long-standing and intractable FERC hydropower proceedings on record.

Dustin also helps utility and independent power producers develop strategic plans for implementing fish passage solutions at existing hydropower facilities, as well as developing new energy projects, including pumped storage and other renewable energy initiatives. His ability to manage diverse stakeholder negotiations and settlements helps clients navigate multifaceted regulatory environments effectively.

In addition to his hydropower experience, Dustin has substantial experience advising utility clients on emerging issues associated with catastrophic wildfires. For years, he has worked closely with utilities across the West and utility industry groups to develop federal and state legislative strategies for mitigating the existential operational, financial, and legal risks utilities are facing due to catastrophic wildfires. His experience in developing legislative solutions and advising on policy matters helps clients mitigate risks and navigate that rapidly evolving regulatory landscape.

Dustin's litigation background, including defending permits and approvals for generation and transmission projects and litigating environmental cost recovery claims, provides clients with robust legal representation in various

forums. His ability to coordinate defense strategies and negotiate settlements that balance regulatory requirements and business objectives is a significant asset to clients facing complex legal challenges.
