REPRESENTATIVE MATTERS

- Obtained a complete jury trial defense verdict in New York state court (Manhattan) on product liability claims for French and U.S. aviation clients in wrongful death action where the plaintiffs sought more than \$100 million.

- Obtained personal jurisdiction and forum non conveniens dismissals of \$100 million commercial claims brought in Texas federal court against a French aviation client following the grounding of the fleet.
- Obtained a dismissal of clients from wrongful death action on the eve of trial after an aggressive defense caused the plaintiff to voluntarily drop the suit with no settlement money paid.
- Obtained a summary judgment dismissal of \$90 million fraud and negligent misrepresentation claims against U.S. and French clients.
- Obtained a summary judgment dismissal with awarded costs on a multimillion-dollar commercial claim against an aviation client in Texas state court.
- Obtained a summary judgment dismissal of a \$25 million contribution claim brought in federal court after a multiple-stage coordinated legal defense strategy involving complex personal jurisdiction, transfer, and choice of law issues, which was upheld on appeal to the U.S. Fifth Circuit Court of Appeals.
- Obtained a summary judgment dismissal of federal court tort and breach of warranty claims against clients based on an economic loss rule defense.
- Obtained a summary judgment dismissal of a manufacturing defect claim brought against a U.S. client in California federal court after the court struck the plaintiff's technical expert on a Daubert challenge.
