### OVERVIEW

Erica is an experienced litigator who represents clients in business and commercial litigation. Erica represents clients from many industries, including manufacturers, retailers, pharmaceutical companies, insurance companies, and petroleum marketers.

In 2024, she second chaired a bench trial in federal court involving breach of contract claims and a bench trial in state court involving legal malpractice claims.
