### OVERVIEW

Boards of directors at major corporations, including pharmaceutical manufacturers, auto makers, energy sector companies, and financial services firms, relied on Gary for seasoned counsel regarding corporate compliance matters and governance issues. Gary has spoken at programs presented by the Society of Corporate Compliance and Ethics, the Institute for Corporate Counsel, the Practicing Law Institute, the U.S. Federal Trade Commission, and the Securities and Exchange Commission.
