OVERVIEW

Kent represents clients in a wide array of litigation matters, including commercial lending disputes, lender liability claims, contract disputes, insurance coverage issues, mechanic's liens, real estate disputes and loan workouts, and receiverships. He has significant experience in regulatory and administrative litigation for health care clients. Kent's clients range from banks and insurers to health care providers, commercial landlords, and developers.

Under that approach, he has represented clients in high-stakes cases, such as a multibillion-dollar case against a bank client arising from a Ponzi scheme.

When warranted, Kent has secured summary judgments for clients in complex contract disputes for bank, insurer, and other clients. His work in administrative and regulatory litigation includes leading teams in appeals of Medicaid audits and defending health care providers against state actions seeking license revocation and administrative penalties.
