### OVERVIEW

Milica (Millie) focuses her practice on complex business litigation, with a particular emphasis on shareholder derivative and securities class action litigation, breach of contract disputes, franchise and distribution disputes, high-value contract matters, and international arbitration. She represents public and private companies, boards, franchisors, insurers, and technology firms — including matters arising out of SPAC transactions — and has assisted in securing early wins through strategic motions to dismiss and focused case management.

Milica handles complex commercial disputes in the United States federal and state courts, as well as in domestic and international arbitrations. She brings an international perspective to cross-border disputes, supported by her fluency in Serbo-Croatian.

Milica frequently authors articles on issues involving securities laws, franchise laws, as well as emerging technologies such as blockchain and artificial intelligence. She explores the intersection of business law and innovative technologies. Her work has been featured in *Law360*, *The Legal Intelligencer*, and other prominent publications.
