OVERVIEW

Neal has more than two decades of public finance experience, serving as bond counsel, disclosure counsel, borrower's counsel, underwriter's counsel, lender's counsel, and trustee's counsel. His work involves a wide range of bond transactions, including general obligation bonds, conduit revenue bonds benefitting 501(c)(3) corporations, taxable and tax-exempt industrial revenue bonds, certificates of participation, and tax-exempt leases.

Neal participates in the financing of various public sector projects, including transportation infrastructure projects, drinking water and wastewater systems, energy efficiency and renewable energy projects, public buildings, open space, airports, stadiums, student loan financings, and multifamily housing developments.
