### OVERVIEW

Nina's trial practice is concentrated in civil litigation, with a primary emphasis in the defense of pharmaceutical and medical device companies regarding marketed products, investigational new drugs, medical devices, and over-the-counter drug products. Nina serves as national coordinating and trial counsel and as regional counsel in pharmaceutical litigation, including class actions and multidistrict litigation.

Nina also represents pharmaceutical manufacturers, consultants, and academic institutions in civil and criminal actions in related complex litigation involving health care fraud and abuse, and the defense of individual and class actions. She has conducted internal corporate investigations, audits, and negotiations with government agencies, as counsel to pharmaceutical companies in grand jury proceedings and multistate investigations. Her practice includes counseling regarding regulatory issues governing clinical trials and compliance in promotional activities, as well as Lanham Act claims in the pharmaceutical industry.

She is the recipient of numerous awards and high national rankings from legal publications, including being named to the "Top 10 Female Litigators" in the U.S. by *Benchmark Litigation*, based on receiving "the most robust and vocal 'best in class' nominations" by peers and clients. She also is a member of the Steering Committee of the Emory Law Institute for Complex Litigation and Mass Tort Claims, which supports the judiciary and the bar by advancing the understanding of new developments and trends in the resolution of mass claims within and outside of litigation.

Through the center, these attorneys study, analyze, and work to resolve problems that affect the lives of people in our communities.
