### REPRESENTATIVE MATTERS

- *California Spine and Neurosurgery Institute v. Anthem Blue Cross et al.*, 2:23-cv-00894-FLA-JC (C.D. Cal. Dec. 2, 2024) – Obtained dismissal with prejudice of all state common law causes of action against Anthem Blue Cross. Plaintiff sought to recover additional benefits based on alleged promises during pre-service communications to pay Usual and Customary Rates. The court ruled that ERISA preempts state common law causes of action arising from pre-service communications and dismissed with prejudice all state common law claims.
