### REPRESENTATIVE MATTERS

- Represented a national mortgage company in purported class action claims involving the Real Estate Settlement Procedures Act and the unauthorized practice of law. The U.S. Court of Appeals for the Fifth Circuit reversed the certification orders.
- Represented a national lender in a lender liability case. After a three-week jury trial, the jury trial returned a defense verdict, and the court awarded the lender its attorney fees and expenses for defending the suit. The U.S. Court of Appeals for the Fifth Circuit affirmed.

Texas Court of Appeals affirmed.
