She also routinely defends companies against consumer class actions involving a variety of consumer protection statutes including, the Telephone Consumer Protection Act, the California Confidentiality of Medical Information Act, and California's Unfair Competition law. She represents clients in both state and federal court, as well as at arbitrations.

In addition to maintaining her practice, Samrah has taught several courses at UC Irvine School of Law, including Antitrust Law and an Introduction to California Federal Local Rules & Filings.

Samrah served as a law clerk to the Honorable Josephine L. Staton of the U.S. District Court for the Central District of California from 2012 to 2013.
