OVERVIEW

Toyja represents large public and medium-sized businesses in complex commercial disputes, focusing on general commercial litigation, construction litigation, professional and product liability, business torts, and insurance coverage. Toyja's clients include construction companies, special event manufacturers, and various others across industries. His trial-to-verdict experience and role as outside general counsel enable him to provide strategic legal guidance and effective dispute resolution.

Toyja is committed to advancing inclusion and raising awareness surrounding mental health in the legal industry.
