OVERVIEW

Whitney concentrates her practice in commercial litigation, with a particular emphasis on securities class action litigation, domestic and international arbitration, appellate work, and complex breach of contract litigation. She has provided successful representation to *Fortune* 500 companies, midsize companies, and national and international clients.

Whitney regularly counsels and offers trainings to a large health care provider on issues relating to ERISA-compliant collection policies, contracts and contract terminations with third-party payors, and disputes associated with reimbursement pursuant to health care plans, network agreements, and single patient agreements.

Whitney maintains an active pro bono practice. Working with the SeniorLAW Center, she has represented low-income seniors victimized by home improvement fraud. Working with the Juvenile Law Center, she represented an individual in an appeal to the Pennsylvania Supreme Court challenging the constitutionality of a de facto life without parole sentence imposed on a juvenile offender.
