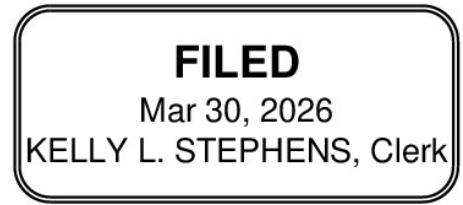



ORDER

In these consolidated matters, the appellants appeal a preliminary injunction that prohibits the Consumer Financial Protection Bureau (CFPB) from enforcing the Personal Financial Data Rights Rule. The plaintiffs-appellees move for an abeyance pending the CFPB’s new rulemaking. The appellants respond separately in opposition, and the plaintiffs reply.

Upon review, and for purposes of docket management, the plaintiffs’ motion is GRANTED, insofar as briefing will be held in abeyance pending further order. The briefing schedule issued March 9, 2026 is CANCELLED. The plaintiffs shall file a status report regarding current rulemaking status every 60 days, with the first status report due 60 days from the date of this order. Each status report shall advise of the appellants’ positions regarding briefing.
